Tyrant Hasina has fallen, but her Indian Loyalists Cronies are still present and are continuing to spread Slander against Hizb ut Tahrir

Tyrant Hasina has been overthrown, but her cronies and the loyalists of India are still in control. These anti-Islamic agents of Hasina are against people's sovereignty and thus conspire to separate the truthful political party Hizb ut Tahrir from the people by spreading lies and slander. Their efforts are failing, because Hizb ut Tahrir is a systematic and intellectual political party with a strong base among the people at all levels. The public is aware that Hizb ut Tahrir is the only party in Bangladesh fearlessly and devotedly brought to light the truth about the brutal Pilkhana massacre of 2009, which was orchestrated by Hasina and India.
